Making of Beeston, Tiverton and Tilstone Fearnall Neighbourhood Plan

Decision Statement published pursuant to the Localism Act 2011 Schedule 38A (9) and Regulation 19 of the Neighbourhood Planning (General) Regulations 2012

Beeston, Tiverton and Tilstone Fearnall Neighbourhood Plan

- 1.1 Work on the Beeston, Tiverton and Tilstone Fearnall Neighbourhood Plan began in 2013, led by a joint working group on behalf of Beeston and Tiverton and Tilstone Fearnall Parish Councils who agreed to define a single Neighbourhood Planning area.
- 1.2 The first formal stage of plan preparation was designation of the Neighbourhood Area. The Neighbourhood Area was designated on 13 June 2013 and covered the same area as the parishes of Beeston and Tiverton and Tilstone Fearnall.
- 1.3 Preparation of the plan has involved significant community involvement throughout, with support provided by Cheshire West and Chester Council and Cheshire Community Action. The Plan seeks to protect the character and distinctiveness of the area, including policies to ensure that development respects existing features and qualities of the built and natural environment; to maintain rural tranquillity, dark skies and key views; to safeguard and sustain community places and access to the countryside; and support appropriate opportunities for employment, retail and connectivity to ensure that residents have access to a range of local businesses, services and social opportunities for a good quality of life.
- 1.4 The draft Neighbourhood Plan and its supporting documents were formally submitted to Cheshire West and Chester Council in February 2017. Following a six week period of publicity, an examiner was appointed with the agreement of the qualifying body. The plan was then subject to examination and the independent examiner's report was received in June 2017. The report concluded that, subject to a number of (relatively minor) modifications, the plan meets the required 'basic conditions' and could proceed to referendum.
- 1.5 On 22 August 2017, the Council's Cabinet Member agreed to accept the examiner's recommendations as well as making an additional change to the area safeguarded under policy T1. Provided that no issues arose during a further 6 week consultation period on the additional amendment, it was agreed that the plan would then proceed to referendum.

1.6 At the referendum held on 30 November 2017, voters were asked to say 'yes' or 'no' to the prescribed question:

"Do you want Cheshire West and Chester Borough Council to use the Neighbourhood Plan for Beeston, Tiverton and Tilstone Fearnall to help it decide planning applications in the neighbourhood area?"

1.7 94% of those who voted said 'yes' to the plan. The outcome was as follows:

Making of the Plan

- 2.1 Preparation of the Beeston, Tiverton and Tilstone Fearnall
 Neighbourhood Plan has now progressed through the prescribed stages
 set out in the regulations with a positive outcome at both independent
 examination and referendum. The plan now forms part of the statutory
 development plan for the area. The Parish Council is to be congratulated
 on a significant achievement in reaching this stage, which would not
 have been possible without the hard work and dedication of the local
 community and in particular the Neighbourhood Plan Steering Group.
- 2.2 The final stage of the preparation process is for the Council to 'make' the Plan. At the meeting of the Council's Cabinet on 11 October 2017 it was agreed that the decision to make a neighbourhood plan be discharged to the Senior Management Planning and Strategic Transport. Decision

- 3.1 That the Beeston, Tiverton and Tilstone Fearnall Neighbourhood Plan be formally made.

The Council is now required to make the plan and no reasons exist as to why this should not happen.
