Notice of Publication of the Central Gowy (South) Neighbourhood Plan

The Neighbourhood Planning (General) Regulations 2012 and Localism Act 2011 Regulation 16

A neighbourhood plan has been prepared for Central Gowy (South) which aims to give local people a greater say about future development in the area. The plan sets out a number of key objectives and policies which it wishes to be used when determining planning applications. The plan covers the area of the former Huxley and Foulk Stapleford parishes and also includes the areas of Bruen Stapleford, Burton and Hatton.

Following a change to the neighbourhood plan area to exclude parts now within Tattenhall parish, the plan has been re-submitted to Cheshire West and Chester Council and a period of publicity will take place between 13 September and 25 October 2017. During this time, any interested parties can make comments on the plan and accompanying documents. Following the publicity period, an independent Examiner will be appointed who will consider the plan and any comments made.
