Dunham on the Hill and Hapsford Neighbourhood Plan Referendum Information Statement

A Referendum relating to the adoption of the Dunham on the Hill and Hapsford Neighbourhood Plan will be held on **Thursday 28 August 2025**

The Question which will be asked in the Referendum is:

"Do you want Cheshire West and Chester to use the Neighbourhood Plan for Dunham on the Hill and Hapsford to help it decide planning applications in the neighbourhood area?"

The Referendum area is identified on the map which is included with this information statement.

The Referendum area is identical to the area which has been designated as the Dunham on the Hill and Hapsford Neighbourhood Area.

Who is entitled to vote?

A person is entitled to vote in the referendum if on **Thursday 28 August 2025.**

- He or she is entitled to vote in a local government election in the Referendum area; and
- His or her qualifying address for the election is in the Referendum area. (A
 person's qualifying address is, in relation to a person registered in the register
 of electors, the address in respect of which he or she is entitled to be
 registered).

You have to be registered to vote by **Monday 11 August 2025** in order to vote in the referendum. You can check if you are registered to vote by calling Democratic Services on 01244 977084. If you are not on the electoral register, you will need to go online to Register to vote - GOV.UK (www.gov.uk) and complete an online application. If you are not registered, then you won't be able to vote.

You are now required to provide photo ID in the polling station, a list of accepted photo ID can be found at Accepted forms of photo ID | Electoral Commission.

If you do not have a form of accepted photo ID, you can apply for a Voter Authority Certificate. Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer at The Portal, Wellington Road, Ellesmere Port, Cheshire, CH65 0BA by 5pm on Tuesday 19 August 2025. How to vote?

There are three ways of voting:

In person on Thursday 28 August 2025. Most people vote in person at their local polling station. A member of staff will always help if you are not sure what to do.

- You will receive a poll card telling you where your polling station is located
- Polling Stations are open from 7am to 10pm
- If you do not receive your poll card, you can contact Democratic Services on 01244 977084 or email us on elreg@cheshirewestandchester.gov.uk

By post:

- To vote by post, fill in an application form and send it to Democratic Services, Cheshire West and Chester Council, The Portal, Wellington Road, Ellesmere Port, CH65 0BA to arrive by **5pm** on **Tuesday 12 August 2025**.
 You may apply online or download a form at https://www.gov.uk/apply-postal-vote or call the Elections Team on 01244 977084.
- Ballot papers can be sent overseas, but you need to think about whether you will have time to receive and return your ballot papers by 10pm on Thursday 28 August 2025.
- You should receive your postal vote about a week before polling day. If it
 doesn't arrive in time, you can get a replacement up to 5pm on Thursday 28
 August 2025.

By proxy:

- If you have a proxy vote already you will receive a poll card confirming this.
- If you can't go to the polling station and don't wish to vote by post, you may be able to vote by proxy. This means allowing somebody you trust to vote on your behalf.
- To vote by Proxy, you will need to complete an application form and send it to the Electoral Registration Officer to arrive by 5pm on Tuesday 19 August 2025 at this address.

- When you apply for proxy vote, you must say why you cannot vote in person.
- Anyone can be your proxy as long as they are eligible to vote and are willing to vote on your behalf. You will have to tell them how you want to vote.

Photographic ID:

New legislation requires electors to show an accepted form of photographic identification at the polling station when voting in person. The deadline to apply for a **Voter Authority Certificate** is **5pm** on **Tuesday 19 August 2025**

Referendum Expenses

The Referendum expenses limit that will apply in relation to the Referendum is £2,392.09. The number of persons entitled to vote in the Referendum, by reference to which that limit has been calculated is 510.

The Referendum will be conducted in accordance with procedures which are similar to those used at local government elections.
