

Notice of Publication of the Dunham on the Hill and Hapsford Neighbourhood Plan

The Neighbourhood Planning (General) Regulations 2012 (as amended)
Regulation 16

A neighbourhood plan has been proposed for the Dunham on the Hill and Hapsford neighbourhood area by Dunham on the Hill and Hapsford Parish Council which aims to give local people a greater say about future development in the area. The proposed plan sets out a number of key objectives and policies to be used when determining planning applications.

The proposed plan has now been submitted to Cheshire West and Chester Council and a period of publicity will take place between Thursday 27 February and 5pm on Thursday 10 April 2025. During this time, any interested parties can make comments on the proposed plan and accompanying documents. Following the publicity period, an independent Examiner will be appointed who will consider the proposed plan and any comments made.

Comments received after this time may not be considered.
