## **Helsby Neighbourhood Plan**

Decision Statement published pursuant to the Localism Act 2011 Schedule 38A (9) and Regulation 19 of the Neighbourhood Planning (General) Regulations 2012

Cheshire West and Chester Council on 8 June 2016 decided to make the Helsby Neighbourhood Plan under Section 38A(4) of the Planning and Compulsory Purchase Act 2004. The Helsby Neighbourhood Plan now forms part of the Development Plan for the Helsby Neighbourhood Area.
