

# Notice of Publication of the Kelsall & Willington Neighbourhood Development Plan

The Neighbourhood Planning (General) Regulations 2012 and Localism Act 2011  
Regulation 16

A neighbourhood plan has been prepared for Kelsall & Willington which aims to give local people a greater say about future development in the area. The plan sets out a number of key objectives and policies which it wishes to be used when determining planning applications. The plan covers the area of Kelsall Parish and also includes small areas within the parishes of Delamere and Oakmere, Ashton Hayes, Tarvin and Willington.

The plan has now been submitted to Cheshire West and Chester Council and a period of publicity will take place between Thursday 14 July and Friday 26 August 2016. During this time, any interested parties can make comments on the plan and accompanying documents. Following the publicity period, an independent Examiner will be appointed who will consider the plan and any comments made.
