Any person aggrieved by the Cheshire West and Chester Local Plan (Part Two) Strategic Policies may make an application to the High Court under section 113 of the Planning and Compulsory Purchase Act 2004 on the grounds that:

- a. the document is not within the appropriate power;
- b. a procedural requirement has not been complied with.

The application to the High Court must be made no later than the end of the period of six weeks starting from the date the Cheshire West and Chester Local Plan (Part Two) Land Allocations and Detailed Policies was adopted.
